Survey Details

Sixty-nine Indian Health Services in Great Plains, Navajo, Bemidji and Oklahoma areas were surveyed and asked if Plan B was available Over-The-Counter (OTC) or has to be prescribed by a health care provider. The survey then asked if any age restrictions apply to Plan B. The report card above reflects the results received from the pharmacies.

The variables that the pharmacies were surveyed on and the point values assigned to them is as follows:

- If the pharmacy provides Plan B, the pharmacy received two points.
- If the pharmacy provides Plan B as an Over The Counter, the pharmacy received two points.
- If the pharmacy requires a prescription for Plan B, the pharmacy received one point.
- If the age requirement to receive Plan B is age 15 and up, the pharmacy received three points.
- If the age requirement to receive Plan B is age 17 and up, the pharmacy received two points.
- If the age requirement to receive Plan B is age 18 and up, the pharmacy received one point.
- If there was no age requirement to receive Plan B, the pharmacy received five points.
- If the pharmacy did not provide Plan B, the pharmacy received zero points and automatically failed.
